AGREEMENT OF COOPERATION

Article 1

Both signatories determine and regulate with this Agreement the areas and matters of mutual cooperation with the aim to develop educational, scientific and other forms of mutual cooperation in higher education according to the interest, the curriculum and in accordance with international legal acts from the domain of higher education, respecting international legal acts, national and local rules and laws.

Article 2

Both signatories shall cooperate in the following areas:

- In developing curricula for undergraduate, specialist, graduate and doctoral studies (and the contracting parties will mutually recognize diplomas accordantly to The Bologna Declaration, taking note of the circurricula complementarity);
- In teaching and research and developing of joint degree programs (based on scientific methods and scientific literature, bibliographic units and scientific works of mutual interests);
- In developing novel teaching methods via e-learning and distance learning;
- In the field of exchanging students, teachers and personnel in the framework of formal mobility programs (with a view to learning, lecturing, consultations and participating in scientific and research work of mutual interest and with a view to work placement and praxis);
- In the field of publishing on the topics of mutual interest, write text books and publish repertoires. They will also organise scientific conferences, seminars, symposia, round tables and public discussions on the topics agreed beforehand;
- In organizing and carrying out joint research projects and mutual exchange of information on research results and publishing scientific papers in the local, national and international scientific journals (or the contracting parties bind themselves to mutual publishing of scientific and expert papers in English, in the local, national and international scientific journals);
- In development of institutional relationships in order to improve the quality in higher education;
- In cooperation of students and student organizations in the field of academic and cultural activities, those enriching students intercultural awareness crucial for successful business communication on a global, national and local level;



- Other areas in which mutual interest in cooperation is established (other sorts of exchange within the scope of the contracting parties incidence).

Article 3

The cooperation based on this Agreement shall be carried out on the principles of reciprocity.

Article 4

All details in realization of the individual activities from Article 2 of this Agreement will be defined by specific agreements, which shall be discussed and agreed by both signatories.

Article 5

This contract has been signed for the period of 10 (ten) years and comes into effect from the moment of its signing.

Both signatories shall consent to mutually inform each other about all circumstances important for the realization of this Agreement.

Either of the institutions may resign this AoC at any time, stating its intention in writing to its counterpart thirty (30) days in advance, after which its decision will be effective.

Article 6

All possible modifications and/or extensions of this Agreement as well as other issues related to the subject of this Agreement shall be concluded in writing and annexed to this Agreement.

Article 7

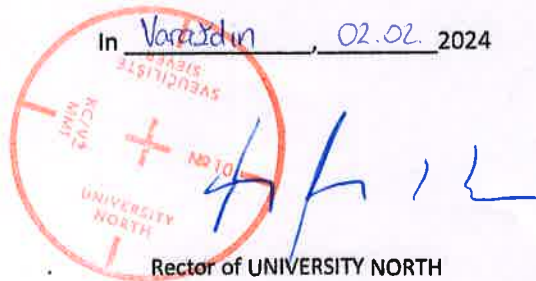
The Agreement is signed in four identical copies in English and each signatory receives two copies.
