

COOPERATION AGREEMENT

between

State Higher Educational Institution "National Mining University" (Ukraine)

and

Lanzhou University of Technology

(Name of the University)

The State Higher Educational Institution "National Mining University" represented by Rector, Academician of the National Academy of Sciences of Ukraine Gennadiy Pivnyak, who acts on the basis of University Statute, from one side, and

Lanzhou University of Technology

(Name of the University)

represented by President, Rui Zhiyuan, Professor

(Name of empowered person, Job position and title)

who acts on the basis of University Statute, from another side, entered into an agreement about a collaboration in educational, scientific research and cultural sphere.

For the purpose of further development of higher education and training of highly skilled personnel, and striving for the achievement of the high level results in the field of research and education, both sides have agreed on the following:

1. To foster development of collaboration on the basis of direct contacts and academic exchange according to the following directions:
 - exchange with expertise in the application of novel methods and facilities in higher education;
 - cooperation in publishing academic and research materials;
 - exchange with academic books and tutorials in the fields of basic specialties;
 - academic mobility of students, post-graduate students, researchers and professors with the purpose of study or internship, acquaintance with research methodologies, use of unique equipment, lecturing, improving professional skills in the partner higher educational institution;
 - participation in joint international educational and research projects;
 - exchange with scientific and technical information, publications, journals and papers which are published by both sides, with respect to the copyright agreements;
 - joint organization and realization of international scientific and technical symposia, conferences, seminars, workshops and round tables;
 - implementation of joint research activities within the frameworks of the national and European programs;
 - implementation of joint technical projects and developments;
 - establishment of direct contacts between researchers and professors of both sides;
 - publication of scientific materials in scientific media produced by both sides.

2. Each side will appoint responsible persons and provide for the implementation of separate agreements in the frames of the directions listed in Paragraph 1 of this agreement.

3. Each party will promote the attainment of funding and grants for the implementation of joint projects, scientific research and academic exchange within the framework of this agreement. The indicated activities of both sides will be accomplished in the frames of mutual planning in order to achieve a synergy of the efforts.

4. The framework of activity for both sides can be extended on the basis of mutual agreement.


