## COOPERATION AGREEMENT

concluded on 1.12.2021 in Wrocław (Poland) between:

Wrocław University of Science and Technology in Wrocław (50-370), Wybrzeże Stanisława Wyspiańskiego 27, Poland,

Oleksandr Shashenko, prof. – Vice-Rector for International Affairs

prof. Tetiana Vvedenska – Head of the Translation Department

The Department of Foreign Languages of Wrocław University of Science and Technology and The Translation Department of Dnipro University of Technology hereinafter referred to as the Parties have concluded the following:

### §1

#### Agreement subject

In order to support the implementation of statutory tasks related to teaching and studying of foreign languages Parties agree to cooperate in the field of didactics and methodology of teaching foreign languages, translation and cultural studies of the taught languages of the countries and languages of which the parties are representatives.

### §2

The Parties shall cooperate in:

- exchange of lectures to teach, conduct consultations, lectures and workshops
- conduct of joint research on methodology of teaching, intercultural communication and intercultural education
- implementation of joint projects using international funds
- publishing and reviewing scientific papers
- participation in conferences, scientific seminars, methodological workshops, etc.
- exchange the experience in the organization of educational process at university
- organization of language courses, practices, workshops and internships for students also run online

§3

Agreement expiration

The Agreement was concluded from the duration period from 1.12.2021 to 31.08.2024. The Agreement is automatically renewed for the period of next 4 years if none of the Parties notifies the other Party in writing of its intention to terminate cooperation under this Agreement.

§4

General conditions

1. The parties, in draft mode, will develop plans for individual projects under this Agreement. The plans, drawn up and accepted by parties, should include specific information concerning the form of tasks implementation.
2. By the mutual agreement of the Parties, this document may be modified by relevant annexes in writing.
3. This Agreement shall be made in four identical copies in English (two copies for each of the Party), whereby all copies are equally valid for each of the Agreeing Parties.
