



COOPERATION AGREEMENT

between

the National Technical University "Dnipro Polytechnic" (Ukraine)

and

Uniwersytet Ekonomiczny w Katowicach (Poland)

The **National Technical University «Dnipro Polytechnic»** represented by Rector, Academician of the National Academy of Sciences of Ukraine **Gennadiy Pivnyak**, who acts on the basis of the University Statute, on the one part, and **Uniwersytet Ekonomiczny w Katowicach** represented by Rector, dr hab. **Robert Tomanek**, prof. UE, who acts on the basis of the University Statute, on the other part, entered into an agreement about a collaboration in educational, scientific research and cultural sphere.

For the purpose of further development of higher education and training of highly skilled personnel, and striving for the achievement of the high-level results in the field of research and education, the Parties have agreed:

1. To foster development of collaboration on the basis of direct contacts and academic exchange according to the following:
 - cooperation in publishing academic and research materials;
 - academic mobility of researchers and professors with the purpose of internship; acquaintance with research methods; use of unique equipment; improvement of professional skills in the partner higher educational institution;
 - participation in joint international research projects;
 - joint organization and realization of international scientific and technical symposia, conferences, seminars, workshops and round tables;
 - implementation of joint research activities within the frameworks of the national and European programs;
 - implementation of joint technical projects and developments;
 - establishment of direct contacts between researchers and professors of both Parties; and
 - publication of scientific materials in scientific media produced by both sides.

2. Each Party will appoint responsible persons and provide for the implementation of separate agreements in the frames of the areas listed in Paragraph 1 of this Agreement.

3. Each Party will promote the attainment of funding and grants for the implementation of joint projects, scientific research and academic exchange within the framework of this Agreement. The indicated activities of both sides will be accomplished in the frames of mutual planning to achieve a synergy of the efforts.

4. The framework of activity for both sides can be extended on the basis of the mutual Agreement.

5. This Agreement becomes operative from the moment of its signing by both Parties. Term of the Agreement is limited to five years. However, the Agreement can be terminated by the intention of any party, about what the other Party must be informed in writing.
