



AGREEMENT OF COOPERATION

in the field of science, technology, and scientific research

Between Dnipro University of Technology (Ukraine), hereinafter referred to as DUT

Av. Dmytra Yavornytskogo 19, 49005 Dnipro, Ukraine

Represented by Rector Prof. Oleksandr Aziukovskyi, PhD

and Rzeszów University of Technology (Poland), hereinafter referred to as RUT

Al. Powstańców Warszawy 12, 35-959 Rzeszów, Poland

Represented by Rector Prof. Piotr Koszelnik, PhD, DSc, Eng.

I.

The Parties of the Agreement will cooperate in the following areas:

- conducting scientific research in the framework of jointly developed research projects,
- exchange of professors, academics, and students,
- exchange of publications, scientific materials, etc.

II.

All of the areas of activities will be agreed upon in the working protocols drawn up for each specific action.

III.

Both Universities will, in accordance with their best capabilities, support guests from the partner university during their stay.

IV.

Both Universities will create the conditions for establishing contacts with other institutions in the field of science, research, education in their country according to the wishes of the partner university.

V.

1. This Agreement does not entail any obligations, including financial commitments, for any of the Parties. The Agreement contains the preliminary principles of possible cooperation of the Parties in the future. The joint projects of the Parties will be implemented on the basis of separate agreements, defining in each case the terms of cooperation, in particular, the obligations of the Parties, timing of their implementation, financial settlements and provisions in the field of intellectual property rights.

2. Should there be a dispute relating to any aspect of academic cooperation, the persons in charge of this affair in both universities will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

VI.

- 1. The Agreement can be modified and supplemented only upon a written consent of both universities.
- 2. Each Party of the Agreement has the right of withdrawal upon written declaration six months in advance.
- 3. The Parties state that they sign the Agreement of their own will, its conditions are sufficiently precise and understandable, and that it has not been concluded on inconvenient terms.
- 4. The Agreement was compiled in 2 copies, one for each Party.
- 5. The Parties undertake to use their best efforts to settle all disputes arising under this Agreement by peaceful means.
- 6. The Agreement is subject to Polish law.
