COOPERATION AGREEMENT

BETWEEN:

Institute of Economy at the National Mining University, Ukraine

AND

Kozminski University, Poland

Hereinafter jointly referred to as "The Parties"
This agreement contains 4 (four) pages.

HAVE AGREED AS FOLLOWS

I. Subject of the agreement

The objective of this agreement is to establish a co-operation between the undersigned Parties. This agreement marks the formal commitment of both institutions to explore practical approaches to creating a mutually beneficial relationship. It aims at promoting academic staff research and improving the educational environment of the undersigned Parties; and developing other specific projects or programs which are not defined, at present, by this agreement.

II. Trends of cooperation

Co-operation shall be carried out through such activities as:

A. Student and Staff Exchange

Both Parties are committed to establishing the student exchange on bachelor and master level, as well as educational exchange of academic staff. Such exchanges may be for short specific courses to longer periods of up to one academic year. The Parties agree to sign a separate Socrates/Erasmus exchange agreement and any further exchange projects supported by their respective national governments and EU authorities.

B. Scholarly Research

The Parties have agreed to identify the common grounds for scholarly research and carry out joint research projects and activities and publications.

C. Promotion of Joint Projects

The Parties have also agreed to promote exchange of knowledge and further educational understanding. It is agreed that both institutions will work together on joint projects for the introduction of the latest business, managerial and marketing developments into the Parties' curricula, and for the implementation of superior educational programs.

III. Further cooperation

This agreement is signed in good faith by both Parties as an indication of joint sincere intention to build upon and develop the already existing mutual respect and confidence that both Parties have for and in each other. Further understanding, if any, would be presented in a separate agreement and would be marked as an addendum to this agreement.

IV. Terms of the agreement

The terms of co-operation for each specific activity implemented under this agreement shall be mutually discussed and agreed upon in writing by both Parties prior to initiation of the activity. The agreement comes into force upon execution by both undersigned Parties.
